Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.

4. FIRST AID MEASURES (ACTION)

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

Ingestion: Do not induce vomiting. Transfer to hospital as soon as possible.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible.

5. FIRE-FIGHTING MEASURES

Extinguishing media: Carbon dioxide. Dry chemical powder. Water fog.

Exposure hazards: In combustion emits toxic fumes of carbon dioxide.

Protection of fire-fighters: Wear self-contained breathing apparatus.

Personal precautions: Eliminate all sources of ignition. Turn leaking containers leak-side up to prevent the escape of liquid.

Environmental precautions: Do not discharge into drains or rivers.

Clean-up procedures: Absorb into dry earth or sand. Refer to section 13 of SDS for suitable method of disposal.

Handling requirements: Avoid the formation or spread of mists in the air.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed.
